ELIGIBILITY & SELECTION CRITERIA

Admission Regulations for the B.A./B.Sc./B.Com (Honours with or without Research/Multidisciplinary) Courses of Studies under Semester system of Examination, for the academic session 2023-2024.

The Essential Criteria

- A candidate who has passed the Higher Secondary (10+2) or its equivalent Examination is eligible to seek admission in the 1st Semester of 6 Semester B.A/B.Sc/B.Com (Honours with or without Research/Multidisciplinary) Courses of studies provided he/she has also passed in English having full marks not being less than 100.
- No candidate will be allowed for admission after a lapse of more than five years of passing of or equivalent examination. The students having year of passing the qualifying examination **before 2020 is not eligible** to seek the admission.
- If the candidates have passed **Vocational Examination (10+2) course** he/she will be eligible to seek admission to the B.A. Multidisciplinary first year course of studies taking the subjects under **Humanities Discipline only** and candidates who have passed the Higher Secondary (10+2) Vocational Examination in **Business & Commerce** conducted by the **West Bengal State Council of Vocational Education and Training** shall be eligible to seek admission to the Three-Year B.Com. 1st year Course of Studies under this University.
- Students seeking admission passed from the **Rabindra Mukta Vidyalaya (10+2)** are offered admission in to BA General Course only and students who have passed from **Rabindra Mukta Vidyalaya (10+2)** in **Business Organization and Management** shall be eligible to seek admission to the Three-Year B.Com. Degree Course of Studies under this University. For **Rabindra Mukta Vidyalaya** Candidates, the marks will be calculated out of 100 per subject.

The Course wise Criteria

For the admission in Honours with or without Research Courses (Basic Criteria)

Honours Subject	Minimum Eligibility Criteria for Admission for the Academic Session 2023-24
BENGALI	Minimum 50% marks in the aggregate and 45% marks in Bengali at previous qualifying examination. Or, The 55% marks in Bengali and 45% marks in the aggregate at previous qualifying examination.
ENGLISH	Minimum 50% marks in the aggregate and 45% marks in English at previous qualifying examination. Or, The 55% marks in English and 45% marks in the aggregate at previous qualifying examination.
HISTORY	Minimum 50% marks in the aggregate and 45% marks in History at previous qualifying examination. Or, The 55% marks in History and 45% marks in the aggregate at previous qualifying examination.
PHILOSOPHY	Minimum 50% marks in the aggregate and 45% marks in <i>Philosophy</i> , 50% marks in <i>Psychology/ Mathematics/ Education/ Sociology/ Political Science</i> at previous qualifying examination. Or, The 55% marks in <i>Philosophy/ Psychology/ Mathematics/ Education/ Sociology/ Political Science</i> and 45% marks in the aggregate at previous qualifying examination.
POLITICAL SCIENCE	Minimum 50% marks in the aggregate and 45% marks in Political Science at previous qualifying examination. Or, The 55% marks in Political Science and 45% marks in the aggregate at previous qualifying examination.

SANSKRIT	Minimum 50% marks in the aggregate and 45% marks in Sanskrit at previous qualifying examination. Or, The 55% marks in Sanskrit and 45% marks in the aggregate at previous qualifying examination.
EDUCATION	Minimum 50% marks in the aggregate and 45% marks in <i>Education or</i> , 50% marks in <i>Psychology/ Philosophy/ Mathematics/ Sociology/ Economics/ Political science/ History/ statistics/ Physics/ Chemistry/ Biology</i> at previous qualifying examination. Or, The 55% marks in <i>Education/Psychology/ Philosophy/ Mathematics/ Sociology/ Economics/ Political science/ History/ statistics/ Physics/ Chemistry/ Biology</i> and 45% marks in the aggregate at previous qualifying examination.
ECONOMICS	A Student shall be allowed to take up Major in Economics if the candidate has passed in Mathematics at the H.S. Examination (10+2) conducted by the West Bengal Council of H.S. Education or its equivalent examination in Mathematics/ Business Mathematics/ Applied Mathematics. Students who have passed Business Economics including Business Mathematics in H.S. (10+2) level from West Bengal Council of H.S. Education are also eligible for admission with Economics as the Major subject, students of Economics Major have to take up Mathematics as one of the Minor subject.
CHEMISTRY	Minimum 50% marks in the aggregate and 45% marks in Chemistry at previous qualifying examination. Or, The 55% marks in Chemistry and 45% marks in the aggregate at previous qualifying examination. ## For Chemistry Major, students should have to qualifying marks in both theory and practical in the pre qualifying Examination in Chemistry& students should have to pass Mathematics, Physics with requisite marks in the pre qualifying examination.
PHYSICS	Minimum 50% marks in the aggregate and 45% marks in Physics at previous qualifying examination.

	<p>Or, The 55% marks in Physics and 45% marks in the aggregate at previous qualifying examination. ## For Physics Honours, students should have to qualifying marks in both theory and practical in the pre qualifying Examination in Physics & students should have to pass Mathematics, Chemistry with requisite marks in the pre qualifying examination.</p>
MATHEMATICS	<p>Minimum 50% marks in the aggregate and 45% marks in Mathematics at previous qualifying examination. Or, The 55% marks in Mathematics and 45% marks in the aggregate at previous qualifying examination. ## For Mathematics Major (Honours), students shall be allowed to take Physics & Chemistry as Minor Subject, if they had passed Physics & Chemistry with requisite marks in the pre qualifying examination. However, the students have Business Mathematics in the pre qualifying Examination can also apply for this Mathematics Honours course.</p>
BCOM(HONOURS)	<p>For B.Com Honours with and without Research , students from the Commerce Background [who have commerce in the prequalifying examination] the related subjects are as follows: Accountancy/ Business Economics including Business Mathematics/ Business Organization/ Mathematics / Business Mathematics/ Economics/ Statistics/ Business Studies/ Office and Secretarial Practice/ Financial Accounting/ Elements of Cost Accountancy & Auditing/ Book Keeping/ Commerce/ Cost Accountancy & Principle of Management/ Commercial Law and preliminaries of Auditing/ Costing and Taxation. A candidate from Science background can also apply for this course. In that case candidate must have 50% in aggregate and 50% in Mathematics.</p>

**** However, candidates belonging to the Scheduled Caste or Scheduled Tribe Community (SC/ST) taking up Honours Course of study must have obtained a minimum 40% marks in the aggregate or 40% marks in the subject or related subject at the previous qualifying examination.**

Multidisciplinary Course/ Three-Year Degree Course	Minimum Eligibility Criteria for Admission for the Academic Session 2022-23
B.COM	<p>For B.Com General, a candidate shall be allowed to take up Three-Year B.Com. Degree Course if he/she had passed the subject(s) at the previous qualifying examination as mentioned below: Accountancy/ Business Economics including Business Mathematics/ Business Organization/ Mathematics/ Economics/ Statistics/ Commerce/ Accounts/ Business Studies/ Financial Accounting/ Office and Secretarial Practice/ Elements of Cost Accountancy and Auditing/ Book Keeping/ Business Mathematics/ Cost Accountancy & Principle of Management, Commercial Law and preliminaries of Auditing, Costing and Taxation.</p> <p>Admission in Three-Year B.Com. Degree Course, the candidate should have 30% marks in aggregate at previous qualifying examination provided he/she has also passed in English having full marks not being less than 100.</p> <p>Candidates who have passed the Higher Secondary (10+2) Vocational Examination in Business & Commerce conducted by the West Bengal State Council of Vocational Education and Training and students who have passed from Rabindra Mukta Vidyalaya (10+2) in Business Organization and Management shall be eligible to seek admission to the Three-Year B.Com. Degree Course of Studies under this University.</p>
B.A	<p>Admission in BA Multidisciplinary Course, the candidate should have 30% marks in aggregate at previous qualifying examination provided he/she has also passed in English having full marks not being less than 100. If the candidates have passed Vocational Examination (10+2) course and passed from the Rabindra Mukta Vidyalaya (10+2) he/she will be eligible to seek admission to the B.A. General Multidisciplinary Course of studies taking the subjects under Humanities Division only.</p>
B.SC	<p>For B.Sc. Multidisciplinary Course, students shall be allowed to take up the subjects Mathematics, Physics & Chemistry, if they had to pass (both Theory & Practical) with requisite marks in the pre qualifying examination provided he/she has also passed in English having full marks not being less than 100.</p>

Formula/Criteria for Calculating Index for Merit List for Admission for the Academic Session 2022-23

For the admission in Honours with or without Research Courses

For the purpose of determining eligibility for admission to the Honours Course, aggregate marks obtained at pre-qualifying examination shall be calculated by adding the marks in top- four subjects in order of marks secured by a candidate. However, the marks obtained in that subject or related subject will be added to total of best of four marks to form order of merit for Honours with or without Research Courses students (i.e., **Best of Four Marks + Major Subject Marks**)

** However, marks in compulsory Environmental Education and Environmental Studies shall not be taken into account for calculation of aggregate marks. If the subject "Environmental Science" is studied as an elective subject of 100 marks, it may be taken into account for the purpose of determining the aggregate marks.

For the admission in Three-Year B.Com and B.A. / B.Sc Multidisciplinary Courses

The **Total of Best of Four Marks** is the only criterion for students in Multidisciplinary Courses (B.A /B.Sc /B.Com).

** However, marks in compulsory Environmental Education and Environmental Studies shall not be taken into account for calculation of aggregate marks. If the subject "Environmental Science" is studied as an elective subject of 100 marks, it may be taken into account for the purpose of determining the aggregate marks.
